





- High level of people working mainly at or from home.




Alfrick & Leigh Ward Profile

The ward is located in the western central area of the district and contains the parishes of Knightwick & Doddenham, Alfrick & Lulsley, Suckley and Leigh & Bransford.

The ward contains a conservation area and two areas of special scientific interest.

Population

In 2011 the total population of Alfrick & Leigh was 3507. The profile of the ward is broadly similar to that of Malvern Hills as a whole but with a greater proportion of 45 to 74 year olds.

The total population has increased by 218 people (6.6%) since the 2001 census with a notable increase in residents aged 60 or over.


Male life expectancy of 77.4 years is the lowest of all the wards with available data and females of 81.6 is the 4th lowest (local health profile tool).



Age profile change 2001 - 2011




Age categories 2001 - 2011




Since the 2001 census there has been an increase in lone parent households in Alfrick & Leigh from 262 to 325 (a 24% rise) and an increase of one family pensioner only households (also 24%). Both of these are considerably higher than the increases seen in the district as a whole.

The composition of households across the ward differs from the district as a whole in that it has significantly more married couple households and significantly less one person households.


Housing




There are 1471 households in Alfrick & Leigh, an increase from 1314 in the 2001 census.

Alfrick & Leigh has a greater proportion of households that are owner occupied than in the district as a whole.

There has been an increase in the number of properties that are owned outright in the ward but there has also been a shift from properties owned with a mortgage or loan to those which are rented.



The majority of properties (60%) in Alfrick & Leigh are detached and just 10% of properties are not either detached or semi-detached. This compares with 26% across the whole of the district. There were an additional 166 household spaces since the last census with the majority being either semi-detached or detached.



There were 41 house sales during 2014/15 in Alfrick & Leigh¹ and the average price for a detached property was £366,945 which compares to £339,514 in Malvern Hills and £320,501 in Worcestershire.

For a semi-detached property the average price was £288,300 compared with £207,532 in Malvern Hills and £187,909 in Worcestershire. There were too few sales in Alfrick & Leigh to compare other property types.

1 Land registry house price index




Overcrowding


There are 1.4% of properties in Alfrick & Leigh which are considered overcrowded (have at least one room less than is required by the occupants).

This is the 2nd lowest figure of the 22 wards and is much less than the average figures for Malvern Hills (3.4%), Worcestershire (4.8%) and England (8.7%).



In Alfrick & Leigh oil central heating accounts for almost 43% of the heating systems in domestic properties whilst gas systems accounts for just 36%. This is significantly different to the district.

Fuel poverty

Fuel poverty in England is monitored using the Low Income High Cost Indicator (LIHC). Under the LIHC definition, a household is considered to be fuel poor if:

- They have required fuel costs that are above the national average
- Were they to spend that amount, they would be left with a residual income below the official poverty line.



In Alfrick & Leigh 17% of households are considered to be fuel poor² and this is above the district, county and national averages.

Economy




There are 2636 residents aged 16 – 74 in Alfrick & Leigh and of these, 69% are economically active, slightly more than the district as a whole. There is a greater proportion of self employed and retired people in Alfrick & Leigh.

In June 2016 there were 10 people aged 16-64 who claimed Job Seekers Allowance which is 0.6% of people. In Malvern Hills 0.9% of people claimed.

Distance travelled to work




There are 462 people who work mainly at or from home in Alfrick & Leigh which is 25.3% of the population that are aged 16 and over and in employment (1736 people). This is the 5th highest of the 22 wards.

The average distance that residents of Alfrick & Leigh commuted the week before the census was 23.9km compared to 18.1km in Malvern Hills. So although there is a large proportion of people that work from home those that do travel to work, commute larger than average distances.

In Alfrick & Leigh there are just 5% of households who do not have a car or van. This compares with 13.5% in Malvern Hills and 16.6% in Worcestershire.

The mean household income in 2013 was £42,5883 which is the 4th highest figure of the 22 wards and higher than the figure for Malvern Hills of £36,694.

Education




There are two primary schools located in the ward. They are listed below along with their latest Ofsted ratings, absence levels and achievements at key stage 2. Both of the schools in Alfrick & Leigh have been rated as outstanding and compare favourably with the county and national averages.

Health and Care



The percentage of people who said their health was good or very good in the 2011 census was higher than the average for Malvern Hills and those who declared their health to be bad or very bad is lower than the Malvern Hills average.

Health is good or very good




Health is bad or very bad




There were 16.7% of people that said their day to day activities were limited which is the 5th lowest of the 22 wards and less than the average for Malvern Hills. Of the population who were aged 16-64, 6.3% had limited day to day activities.

Aged 16 to 64 and activities limited




There were 478 residents in Alfrick & Leigh who provided unpaid care at the time of the 2011 census which is 13.6% of the population. This has increased form 10.9% since the 2001 census.

There are greater levels of carers than the district as whole which in turn has more than Worcestershire and England.




Crime and Community Safety




There were 104 crimes reported in Alfrick & Leigh between April 2015 and March 2016.⁴ The average number of crimes across all the wards in Malvern Hills is 151 during the same period. These 104 crimes equate to 30 crimes per 1000 residents which is the tenth lowest level across the 22 wards.

During the same period there were 66 Anti-social behaviour (ASB) incidents in Alfrick & Leigh. The average number of ASB incidents across all the wards in Malvern Hills is 86. This figure of 66 in Alfrick & Leigh equates to 19 incidents per 1000 residents and is the ninth highest of the 22 wards.

The four main crime categories are burglary, criminal damage, violent crime and vehicle crime. Between April 2015 and March 2016 the number of crimes per 1000 residents for three of these categories were below the ward average with only burglary being slightly above the ward average.

Deprivation



The 2015 Indices of Multiple Deprivation (IMD) ⁵ calculates local measures of deprivation and indicates where each small area ranks across the country. Each small area, on average contains around 1500 properties and the lower the rank, the more deprived an area is.

Seven domains of deprivation are combined to produce the overall IMD. The Alfrick & Leigh ward contains two small areas and overall, the IMD puts these areas in the 6th and 7th decile nationally (where the 1st decile contains the 10% most deprived areas).

Only the Barriers to Housing and Services and Living Environment domains fall within the most deprived 40% of areas nationally.

Each of the seven domains have several indicators that are combined to establish the score that places them in the deciles above.

For the small areas in Alfrick & Leigh that scored poorly on the Barriers to Housing Services domain, the areas that contributed to this poor score were the road distances to a primary school, post office, general store or GP surgery.

For the Living Environment domain the primary reasons were the number of houses in that fail to meet the decent homes standard and the number without central heating.

Deprivation



The dimensions of deprivation are calculated from census data and are used to classify households based on the following four household characteristics:

Employment - any member of a household not a full time student is either unemployed or long-term sick

Education - no person in the household has at least level 2 education and no person aged 16-18 is a full-time student)

Health & disability - any person in the household has general health 'bad or very bad' or has a long term health problem)

Housing - Household accommodation is either overcrowded, with an occupancy rating of - 1 or less or is in a shared dwelling or has no central heating.

A household is classified as being deprived in none, or one to four dimensions in any combination.

There are just over 16% of households in Alfrick & Leigh that are considered deprived in 2 or more dimensions which is the 7th lowest of the 22 wards and lower than the Malvern Hills, Worcestershire and England averages.
