## **PLANNING COMMITTEE MINUTES**

**Minutes of the meeting held Tuesday 25<sup>th</sup> June 2024, 7.00pm at Leigh & Bransford Memorial Hall**

In attendance: Cllrs D Fereday, J Sharp, P Ralph, P Hawkins, M McNally

Members of Public: Approx. 40.

1. Apologies. Cllr Christie, Cllr Cresswell, Clerk: Anna Briggs

2. Register of interests. None

(Meeting closed)

3. Public participation. Member of the public voiced their concerns about the planning application M/23/01119/FUL which seeks to establish a holiday caravan park at the corner of Lower Howsell Road and Malvern Road, Leigh Sinton.

There was confusion about whether the application was for touring caravans, static caravans or lodges. The density of caravans on the site was felt to be excessive.

Questions were raised as to whether it was a holiday park or residential. The application was for the caravans to remain on the site for 12 months and this points to long term occupation, not holiday use.

The road network is unsuitable for increase in traffic volumes. The Malvern Road and Lower Howsell Road are not safe for cycling and walking to Malvern. The roads are subject to flooding and the noise and pollution levels from stationary vehicles on the Malvern Road would be unacceptable.

Leigh Sinton does not have facilities to support holiday makers with one small shop/Post Office, a take-a-way and a small pub. Crossing the road from the site to access these facilities would be difficult with the volume and speeds of vehicles on the Malvern Road and very dangerous at night as there are no street lights. If the caravan occupants require access to tourist attractions they would have to use a vehicle.

Concern was expressed about drainage, both surface and foul water and the capability of the infrastructure to cope. Concern was expressed about how the site had been cleared before an environmental survey was undertaken which may have resulted in any valuable species of plants or invertebrates being destroyed. It was pointed out that Carey's Brook runs adjacent to the site and this contains an endangered aquatic species which could be destroyed by polluted run-off from the site.

The site was in the Significant Gap and outside the development boundary for Leigh Sinton.

The planning history of the site was mentioned and that past appeals by the owners had all be rejected by government inspectors over the years.
